In furtherance of that mission, DHPA created a State Health Policy Action Fund to support DHPA's member practices that are engaged in legislative or regulatory issues on the state level that pose threats to—or create opportunities to enhance—independent GI practices' ability to deliver accessible, quality care to our patients.

DHPA member practices that are in need of financial assistance in their state-level advocacy efforts are invited to submit an application requesting grant monies from the DHPA State Health Policy Action Fund. All grant applications will be reviewed and acted upon by DHPA's State Health Policy Committee.
